TWY and Parking Stands layout incorrect.

Jeppesen Airport Moving Map and A816 formatted data for cycle 2412, effective 28 November 2024, contain incorrect data for Ras Al Khaimah Intl; Ras Al Khaimah, UAE (OMRK). UAE AIP AIRAC AMDT 12/2024, effective 28 November 2024, has been postponed by NOTAM A3863/24, effective 28 November 2024 at 12:15 [UTC], after 2412 AIRAC cycle data processing due date. Therefore, the following changes, effective 28 November 2024, are not reflected in cycle 2412 data:

- TWY N1 and TWY S1 names are removed
- Parking Stands 17-19 (between TWY N and S) are added
- o TWY (between TWY N and S) is added
- Parking Stands 1-16 layout is updated
- Taxiline (north of TWY N) layout is updated


